## Recommendation

**Be it resolved that** Finance Report FIN-2025-03 dated March 27, 2025, regarding the Remuneration of Members of Council and Council Appointees be received and that Council approve the report in accordance with section 284 of the Municipal Act, 2001.

## Background

Section 284 of the Municipal Act, 2001 requires the Municipality to submit a Statement of Remuneration, Benefits and Expenses paid to Members of Council and Council Appointees by March 31 of the year following. This report provides the information being submitted for 2024.

Municipal Act Section 284 (1):

The treasurer of a municipality shall in each year on or before March 31 provide to the council of the municipality an itemized statement on remuneration and expenses paid in the previous year to;

1. Each member of council in respect of his or her services as a member of the council or any other body, including a local board, to which the member has been appointed by council or on which the member holds office by virtue of being a member of council;
2. Each member of council in respect of his or her services as an office or employee of the municipality or other body described in clause (a); and
3. Each person, other than a member of council, appointed by the municipality to serve as a member of any body, including a local board, in respect of his or her services as a member of the body.
