Recent Investigation and Updates

- Gave two verbal warnings to snow removing contractors regarding Clean Yard By-Law,
 Ref.: when cleaning a customer's driveway not to blow or push the snow onto a neighbouring property. (They complied).
- The BEO gave a verbal warning and written warnings to property owners and snow removing contractors who were pushing their snow into Municipal ditches and onto roads and streets.
- Delivered a Clean Yard Order to Comply to a landlord, Ref.: to remove garbage, recycling and furniture that his tenant had placed outside on his property. (They complied).
- Delivered a letter to a property manager extending their compliance date to finish the list of repairs that was required in a previous Order to Remedy Violations of Standards of Maintenance and Occupancy.
- For the safety of pedestrians, a property owner was told to remove two large icicles that were hanging from the roof of his house that was located close to two Municipal sidewalks.
- Received two dog complaints, but both plaintiffs couldn't identify the dog owners. I only had limited descriptions of the dogs and their owners.
 I patrolled many times the Prescott-Russell Recreational Trail between the intersection of Pearl and Barton Road but had no luck in finding the owner of the dog that bit a person.
- A property owner was told to move back his recycling and garbage bins onto his property, so they won't obstruct Public Work snow removal operation. (They complied).



 BEO had to resolve a dispute between a citizen of Champlain Township and the President of the Eastern Ontario Snowmobile Club, Ref.: the location of the Snowmobile trail passes in front of his property.

School Crossing Guard

- Carried out some crossing guard surveillance.
- I replaced one crossing guard for one shift.
- I had to use a substitute crossing guard for forty shifts to replace some absent crossing guards.
